

Fire Risk Assessment:

Comprehensive systematic general Fire Risk and Specific Fire Risk Assessment can be carried out depending up on the requirement for various compliance.

These Include:

- ☞ Life Safety Fire Risk Assessment.
- ☞ Fire Risk Assessment to minimise the potential extensive property loss in the event of a Fire incident is conducted in accordance with the relevant standards and code of practice. Also supporting documentary images will be provided.
- ☞ Risk ratings are assigned using a matrix that takes into consideration of life/property loss potential.
- ☞ A detail Risk Assessment report will be as per standard format or as per statutory requirement. Also CAD detail drawing denoting the entire Fire Protection system location including the type First-Aid Fire fighting appliances can be prepared.

Additionally:

- ☞ Post assessment support includes technical advice and a technical information package to help the clients to address significant findings and assist with ongoing Fire Prevention and Protection management system.
- ☞ Where complex fire safety deficiencies are identified, special advice by the expert Fire Engineering personnel can be made available.

Fire Safety Audit:
